TERMS AND CONDITIONS

1. Application for hire of the Company's Electronic Timing equipment or Open Water Equipment must be in writing and lodged at the below address a minimum of 28 days prior to the date required. Please note that bookings are allocated on a 'first come, first served' basis. All hire equipment should be organised directly with the Swimming NSW office.
2. The following indemnity must be signed by an authorised Club or Area member before a booking can be confirmed.
3. Full payment of Equipment Hire charges may be requested before a booking can be confirmed. The balance and any additional costs incurred by Swimming NSW during the Hire will be invoiced upon completion of the booking.
4. If Swimming NSW is unable to fulfill your booking, under any circumstances following receipt of payment, a full refund will be provided.
5. It is the responsibility of the Club/Area to return the Open Water Equipment to the Sydney International Regatta Centre.

INDEMNITY

We agree to be liable for and to indemnify Swimming NSW Ltd. with regard to any liability occasioned by or through the use of the Company's equipment during the period of hire.

In particular, we agree to be liable for and to indemnify the Company with regard to:

1. Breakage or damage to the hired equipment;
