PRESIDENT'S REPORT



On behalf of Swimming NSW (SNSW), I am delighted to present the 128th Annual Report. As we reflect on the past twelve months, I am proud to report on a year defined by significant progress under SNSW's Strategic Plan. In a year where momentum has clearly been building across our sport, our collective efforts in performance, participation, and partnerships have positioned NSW strongly as we move towards 2032 and beyond.

PARTICIPATION: BUILDING A MORE INCLUSIVE AND INFORMED COMMUNITY

Participation remains central to our future. In 2024, we deepened our understanding of the challenges facing clubs through a statewide club survey and winter pool access audit. With more than one-third of affiliated clubs responding, this valuable data is helping SNSW and the Participation Committee shape our statewide Participation Strategy and enabling us to advocate more effectively on behalf of the swimming community. We are grateful to the clubs that contributed to this process.

Informed by this data, SNSW has been actively working with Swimming Australia on the National Participation Strategy, ensuring that the unique needs of NSW clubs and



swimmers are reflected in national approaches to facility access, membership, and club sustainability.

At the heart of participation is inclusion. This year, SNSW led the way nationally in providing accessible competition and classification opportunities for para swimmers. Eight Multi Class Classification Days were held, including our regional classification event in South Grafton, a collaboration with Swimming North Coast. This initiative removed travel barriers for regional swimmers with a disability, offering on-site classification alongside inclusive coaching and a swim meet that drew record attendance. The third annual NAIDOC Week Relays were another participation highlight, held during the SNSW Country Short Course Championships. With team names inspired by water animals, drawn from the Dharug Language, the traditional language of the Wann-gal People on whose land the championships are held, six teams and 21 Indigenous swimmers from across NSW took part. The event blended cultural pride with competition in a short relay format that continues to grow and inspire. The Country Championships were standout, bringing together 1,167 swimmers from 99 clubs. The spirited Digital Parade of Clubs saw the return of vibrant regional energy to SOPAC and this event exemplified what swimming competitions should be: aspirational, accessible, and fun.

PERFORMANCE: CREATING OPPORTUNITY AND CELEBRATING EXCELLENCE

Performance success is a shared endeavour, nurtured by clubs, coaches, officials, and families and the results achieved this season are testament to the collective strength of our community. SNSW has continued to deepen its investment in the performance pathway through the expansion of squad programs, increased engagement with coaches, and the reintroduction of international touring teams – critical to elite athlete development.

While the CEO's Report rightly acknowledges the standout achievements of NSW swimmers at the Paris Olympic and Paralympic Games and the Japan Tour, I'd like to highlight another area of outstanding contribution, our Technical Officials (TOs). Our officials are the custodians of fair competition and play a vital role in shaping the experience of every swimmer. This year, we were proud to see two of our most experienced TOs, Faye Lewis and Murray Smith, officiate on the world stage at the Paris Olympics, World Championships in Budapest, and Para World Series in Fiji. Their commitment and excellence are an inspiration to all.











PARTNERSHIPS: STRENGTHENING RELATIONSHIPS TO GROW OUR SPORT

SNSW continues to place a strong emphasis on building partnerships that create long-term value for our members and our sport.

This includes working with the NSW Government to advocate for continued investment in aquatic infrastructure and to ensure affordability and access to world-class facilities such as the Sydney Olympic Park Aquatic Centre (SOPAC). Our ongoing relationship with SOPAC remains essential to the successful delivery of our swim meets and Performance Centre.

2025 saw the establishment of the SNSW Participation Committee, bringing together club leaders and subject matter experts to support Management in the development and delivery of our Participation Strategy. This initiative is already helping us better align operational decisions with the lived experience of clubs, coaches, and swimmers.

We were also thrilled to see New South Wales so prominently represented at the 2024 Swimming Australia Awards, held in Brisbane in September. Tim Hodge was named Paralympic Program Swimmer of the Year for his remarkable performances at the Paris Paralympics, earning two gold medals and a silver. His coach, Misha Payne, was recognised as Paralympic Program Coach of the Year, a testament to his role in guiding Tim and other athletes to world-class success. Rising open water talent Chloe Brodrick received the Flipper Athlete of the Year award following her outstanding performance at the World Junior Championships in Italy.

Ariel Darley was honoured as Local Legend of the Year for her tireless volunteer contributions across club, area, and state levels, exemplifying the spirit of community that underpins our sport. Lane Cove Swimming Club was named Club of the Year, recognising its exceptional growth, innovation, and inclusive community focus. We congratulate all award recipients for their inspiring achievements and their contribution to the ongoing strength of swimming in New South Wales.

LEADERSHIP TRANSITION: BUILDING A STRONG LEGACY

I officially assumed the role of President in November 2024 following the election of Chris Fydler OAM to the Swimming Australia Board as Interim President. On behalf of the Board, I congratulate Chris on this appointment and thank him for his extraordinary service to SNSW over the past five years. Chris was instrumental in revitalising our organisation, overseeing the implementation of the 2022–2032 Strategic Plan and driving modernisation across our systems and processes. His leadership navigated us through significant challenges, from natural disasters and the COVID-19 pandemic to the delivery of strong performances by NSW athletes on the world stage. He leaves our sport in a strong and sustainable position, and I look forward to building on this foundation as we continue to move forward.

LOOKING AHEAD

Our vision remains clear: to be the number one state for performance and participation. Achieving this will require continued unity and shared purpose. On behalf of the Board, I extend my sincere thanks to CEO Kirsten Thomson OLY and the staff of SNSW for their outstanding leadership and commitment in delivering a significant turnaround for the organisation. Their work has strengthened our foundations and set us on a clear path toward sustainable growth. I would also like to thank our member clubs, Technical Officials, committee members, and volunteers across the state for their continued dedication and passion. To my fellow Board Directors, thank you for your strategic guidance and tireless advocacy on behalf of

our community. Finally, I extend our deep appreciation to all our partners and stakeholders, your support continues to be instrumental in driving our sport forward.

Together, we are creating a stronger, more resilient swimming future for New South Wales.

CEO'S REPORT



It has been a pivotal year for SNSW one defined by growth, revitalisation, and renewed focus as we continue to pursue our bold vision of returning NSW to number one for performance and participation. Across the state, our sport has evolved in meaningful ways, driven by a deep commitment to innovation, inclusivity, and connection with our members.

Our achievements this year reflect the incredible people who bring swimming to life in NSW. From our swimmers to coaches, officials, parents, and volunteers—thank you. Your tireless efforts, passion, and commitment are the foundation on which our progress is built.

A key focus in 2024 was improving how we engage and communicate with our members. Through targeted email campaigns, dynamic social media channels, and the continued delivery of *Hot Off the Blocks* and *Splash News*, we have deepened our connection with the swimming



community. SNSW also introduced post-event surveys across clinics and events to better understand member needs, and these insights have helped shape improvements in delivery and experience. In 2025, we look forward to launching our new website that will seek to improve member experience, provide all swimming content in one central location, and foster connection amongst the NSW swimming community.

We introduced the SNSW Club Engagement Series, a dedicated initiative providing webinars and development opportunities for clubs and volunteers. Our Club Support Officer network transitioned to a statewide model, significantly increasing visibility, and providing tailored support to clubs across NSW and we introduced a Club Marketing Toolkit to support grassroots growth. We are grateful to the parent volunteers who lead and support our clubs and Areas, they are the backbone of our sport.

Enhancing the value of membership remained a strategic priority. In addition to core offerings like insurance and event access, SNSW delivered exclusive partner benefits from providers and continued to expand commercial relationships that support both members and the broader organisation. These offers were complemented by sampling programs, promotional campaigns, and tools to help clubs better promote the value of being part of the SNSW community.

Commercial success has been key to restoring SNSW's pre-COVID financial position. New partnerships with DOOLEYS Clubs and Veriu Hotels Macquarie Park delivered added member benefits, while improved terms with Speedo and increased support from the NSW Office of Sport and Swimming Australia boosted revenue. Swim Shop earnings grew by \$84,185, driven by a refreshed marketing strategy and stronger online sales. These gains strengthened our finances, added member value, and highlighted the power of strategic partnerships in driving SNSW's growth.

Participation continued to flourish across the state with growth in memberships and increased participation at SNSW events. Over 16,000 swimmers participated in SNSW events, an increase of 3% from the previous year and a testament to the continued strength of our sport. The 2024/25 season saw record-breaking attendance at the Senior State Age Championships, with over 1,400 swimmers delivering more than 4,850 individual swims. The level of competition showcased the depth of talent within our swimming community and post-event feedback was overwhelmingly positive, reinforcing the event's standing as one of the premier age-based competitions in the country.



SNSW events would not be possible without our amazing Technical Officials, over 2,030 officials volunteered across 85 sessions. We are committed to supporting the development of Technical Officials through both local and national opportunities and providing increasingly enjoyable environments for those that generously give their time to support our swimmers.

We continued our statewide focus through innovative regional initiatives and events. A standout moment was the inaugural *Swim Sampler Weekend* in Wagga Wagga, held in partnership with the Southern Inland Swimming Association. Featuring a mix of clinics and participation events, it brought together over 170 swimmers of all abilities. With strong community engagement, enthusiastic feedback, and valuable exposure to elite coaching in a regional setting, the initiative demonstrated the power of innovative event formats in driving participation and supporting regional development.

The 2025 NSW Country Regionals were a weekend of incredible swimming performances, community engagement, and team spirit. Held across three locations— Taree, Griffith, and Gulgong—this year's events brought together over 2,000 swimmers, spectators, and volunteers. The events showcased exceptional swimming talent and highlighted the importance of community, cultural recognition, and teamwork. The inclusion of cultural elements added depth and meaning, reminding all participants of the land's rich heritage. SNSW would like to thank the local councils, Areas and clubs that made this event possible.

Investment and innovation in performance pathways continue to support the state's return to becoming a strong contributor to Australian swimming competitiveness. Congratulations to the NSW athletes that represented Australia across junior and senior teams throughout 2024/25.

At the 2024 Paris Olympic Games, NSW was represented by Bronte Campbell, Olivia Wunsch, See-Bom Lee, William Yang, Bradley Woodward and coach Adam Kable. These swimmers brought home two gold and a silver from one of the most competitive Olympic programs on record.

The 2024 Paralympic Games featured Chloe Osborn, Jasmine Greenwood, Timothy Hodge, Jesse Aungles, Ella Jones and coaches Misha Payne and Marty Roberts. Impressive performances resulted in two gold and two silver medals from the NSW contingent. These athletes and coaches performed brilliantly in Paris, and we are proud of their achievements.

The year also marked a return to international competition for the first time in five years, with the SNSW Touring Team travelling to Japan. Our athletes, led by head coach Shannon Rollason, delivered outstanding performances, winning twelve medals at the Japan Open. Providing

international competition opportunities for NSW will be a cornerstone of our Performance & Pathways Program as we head towards a home Games in 2032.

Domestically, participation in our Performance Pathways Program continued to grow, encompassing five squads, one touring team, and 184 swimmers and 67 home coaches engaged during 2024/25. We also introduced new talent development initiatives including regional and junior programs, designed to build depth and readiness across Olympic and Paralympic pathways.

Para swimming took a significant step forward through our strengthened partnership with the New South Wales Institute of Sport (NSWIS) and the creation of the NSWIS Para Unit. This collaboration will be critical in building inclusive pathways for emerging and elite para athletes. Additionally, SNSW delivered eight Para Classification days, including our first ever regional classification event in partnership with Swimming North Coast.

SNSW would like to thank everyone who generously contributed to our activities. The team at SNSW are immensely appreciative of the continued support and recognise that these contributions are vital to the ongoing development of our sport. Our shared journey is made possible by our valued partners, including Speedo, DOOLEYS, Veriu, NSWIS, ACTAS, SCTA NSW, the NSW Office of Sport, Swimming Australia and our Performance Centre partners—NUsport, Sydney Olympic Park Aquatic Centre, and the Sutherland Shire Council. This support enables us to create opportunities for swimmers to pursue their ambitions.

Finally, I would like to thank the entire team at SNSW—our staff, coaches, and Board, for your unwavering commitment to our organisation. There is a sense of momentum building across NSW, a belief that we are on the path to an exciting future. Together, we are creating a stronger, more connected, and inclusive sport—and positioning NSW as a leader in the national and global swimming community.

MEMBER ENGAGEMENT

In 2024/25, SNSW refined its communications strategy to better engage with member segments. While continuing to provide regular updates to Area Presidents and Secretaries, we also communicated directly with members via targeted database emails and social media channels and groups.

Recognising that individuals move through different roles within our community, this segmented approach allows relevant information to reach the right audience. SNSW delivered direct communications on a wide range of topics, including:

- » Updates to national insurance arrangements direct to clubs
- » Introduction of the new coach event accreditation, shared directly with coaches
- SNSW rule changes, including updates aligned with World Aquatics and Swimming Australia to support broader participation in events shared with Areas and Clubs.
- » Sponsorship announcements and Director appointments shared with all members.
- » National Integrity Month campaigns and Active Kids Voucher information.

Two email newsletters, alternating fortnightly, supported these communications:

- » Hot Off the Blocks targeted at Club Committee Members
- Splash News to all members, providing a roundup of news and upcoming events

To improve access to information, the news section of the SNSW website now acts as a central hub, mirroring content shared via emails and social channels, ensuring members can easily find updates.

Tailored communications also continued to be delivered to key groups. Through the quarterly Technical Officials Newsletter SNSW shared updates on rule changes, upcoming national and international appointments, along with recognition for outstanding achievements in officiating. Engagement has continued to grow in our dedicated Facebook groups for Coaches and Technical Officials, where ongoing updates foster connection and community among these vital member segments.

SNSW implemented surveys across key areas of the business, including clinics and events, to boost member engagement and ensure insights directly inform decision-making. The feedback gathered has been instrumental in guiding meaningful improvements to the delivery of these initiatives.

Club support and engagement

SNSW Club Support Officers (CSOs) continued to deliver participation, development, and administrative support to clubs across the state. Since transitioning to a statewide model in 2024, engagement with this service has significantly increased, with more clubs now seeking tailored assistance from SNSW.

In early 2025, SNSW launched the *Club Engagement Series* – a program of webinars and engagement opportunities designed to drive club development across NSW. The series includes sessions on topics such as Swim Central skill development, governance, administration, and other key areas aimed at helping clubs to thrive. Additionally, SNSW has empowered our 12 Areas to host webinars for their respective clubs, with SNSW CSOs attending to provide expert guidance on member engagement, retention, governance, Swim Central administration, marketing and more.

In August 2024, SNSW collaborated with Areas to collect data on pool opening and closing dates throughout the winter season. This vital information is informing SNSW's planning and decision-making processes to better support club operations and ensure long-term sustainability of the sport. SNSW will work in partnership with Swimming Australia as part of the National Participation Strategy to use this information to advocate for improved facility access.

As part of this data collection process, SNSW conducted a comprehensive club survey to gain insights into club strengths, challenges, and perceived barriers to participation. With responses from more than one-third of affiliated clubs, the survey provided valuable data that is helping SNSW and its Participation Committee shape future participation initiatives. We extend our sincere thanks to the clubs that contributed to this important initiative.

Our CSOs continue to manage the SNSW Committee Members Facebook group—an active online community with over 1,000 members. This platform enables club representatives to share ideas, ask questions, and support one another in managing club requirements.

Area Presidents Committee

The SNSW CEO and President met on a regular basis with Area Presidents to seek feedback on critical matters that impact our sport. These meetings were supported by frequent Area President & Secretary memos detailing key information and announcements.

SNSW appreciates the collaborative approach taken by Area Presidents to improve decision making across many facets of our sport. These meetings have contributed to several positive outcomes including:

» Implementation of the revised Area Development Program



- » Feedback on proposed future membership models
- » Consideration of potential regional events and improvements to Country Regionals
- » Navigating the challenging cost of living environment
- Developing ideas for consideration within the SNSW Participation Strategy
- » Feedback on the delivery of SNSW championship events
- » Future event calendars and opportunities

SNSW would like to congratulate the Areas that have actively developed new products and initiatives that have supported the development of swimming across NSW including (but not limited to) the Swim Sampler Weekend (SISA), regional multiclass classification event (SNC) and the inaugural Miklin Metro Show Down (SMNE), details of which follow.

SNSW Directors also attended Area AGMs to provide an update from SNSW and provided the opportunity for members to ask questions during these sessions.

The delivery of our sport is a team effort, and we are grateful for the many volunteers that generously give up their time and expertise to support the ongoing evolution of swimming in NSW.

MIKLIN METRO SHOWDOWN – LAUNCHING A NEW ERA OF AREA COMPETITION

In 2024, the NSW Metropolitan Areas united to deliver the inaugural MIKLIN Metro Showdown, a new, high-energy event designed to foster competitive spirit and collaboration across the four Metro Areas. Hosted as a one-day team-based competition, the event featured 96 athletes who competed across a program of both traditional and non-traditional races. Athletes earned points for their respective Areas in each race, with the final point scores determining the overall champions and distribution of the \$5,000 prize pool.

The concept, led by Metro North East, championed by Development Convener Luke Bibby and developed by Metro Area representatives, aimed to reinvigorate inter-Area rivalry while providing swimmers with a dynamic and engaging race environment. With smoke machines, enthusiastic crowd involvement, and a festival-like atmosphere, the Showdown was designed to showcase the fun and competitive side of swimming in equal measure.

Thanks to the contributions from all four Metro Areas, as well as the generous support of Lane Cove Optical, JVIA Nutrition, and major sponsor Miklin & Co, the event was delivered successfully and with strong athlete and coach engagement. Metro North East finished the day as the overall winners of the inaugural event.

The MIKLIN Metro Showdown is now positioned to become a key fixture on the Metro calendar, offering a platform for athlete development and team pride. Planning is already underway for its return in 2025.

EFFECTIVE COMMUNICATION AND WELL-PLANNED PROGRAMS

Website Redevelopment

In response to member feedback and the need to modernise our digital infrastructure, SNSW underwent a comprehensive review of its current websites. This process identified critical issues including outdated technology and a fragmented user experience across the main website and the Club House platform. A new website is in development, designed to consolidate both sites into a single, secure, and user-friendly platform. The new site will feature improved functionality, enhanced integration with Microsoft 365 systems, and a more streamlined experience for members, clubs, and stakeholders. Built with direct input from members and end users, the project ensures the platform will better support the needs of our community into the future.



Club Marketing Toolkit

SNSW refreshed the *Club Marketing Toolkit* to better support clubs with their local promotional efforts. The updated toolkit is designed to help clubs drive year-round membership growth and includes a suggested calendar of promotional activities. In 2024, the toolkit featured 13 social media tiles with example captions, seven editable poster templates, a member benefits poster, top tips for promoting club activities, and easy-to-follow instructions for customisation. These resources were distributed through Hot Off the Blocks and made available for download on the SNSW website.

Notably, sign-up rates at the beginning of the membership season were significantly faster than in previous years. This positive trend is credited in part to improved communication strategies and the introduction of the refreshed marketing toolkit. By equipping clubs with user-friendly, locally focused materials, SNSW supported stronger outreach and engagement within communities.

Building on this momentum, SNSW will continue to enhance club marketing resources in direct response to club feedback, ensuring ongoing support for local growth and participation.

Member Benefits

We are proud that SNSW continued to deliver the best value membership in the country, ensuring our members received more while supporting and growing the sport they love.

DEVELOPING AND RETAINING OUR VOLUNTEERS

SNSW takes great pride in the development and retention of Technical Officials (TOs) across the state. Our recent history of representation at national and international level is unmatched in this country, and we have many grassroots officials across the state from small rural clubs to large metropolitan clubs. We are proud of our TOs and grateful for their contribution.

SNSW and its Technical Swimming Committee (TSC) recognise the challenges in attracting and retaining TOs, and that this challenge is growing as lifestyle habits change and cost of living rises. Less volunteers are becoming involved in all sport nationwide, and SNSW is committed to curbing the trend. Over the past year, with the TSC, SNSW created metrics to measure our performance in this area, significantly increased our funds reimbursed to state officials, engaged in development activities and provided resources to potential, new, and existing officials.

2024/25 TO initiatives included:

- The continuation of the free annual Referee course designed to provide opportunities for TOs to become accredited as a Referee within 12 months (dependant on their experience prior to the course).
- » Implementation of the inaugural Young Officials Program, focusing on attracting young people between the ages of 16 and 25 to swimming officiating, aiming to understand their perception of officiating, barriers to participation, and providing them with opportunities to officiate.
- » Engagement with Swimming Australia to assist with several Technical Official objectives:
 - Streamlining online training for TOs by transferring ownership of the online courses previously owned by SNSW
 - Participating in workshops and encouraging officials to complete surveys to help shape the national officiating action plan.
- Sontinuation of targeted content and communication through the NSW Technical Officials Facebook Group – a community of wonderful, like-minded individuals who share a passion for officiating and wish to learn from and/or provide mentoring to other officials – and the Technical Official newsletter.
- » A commitment of a further \$10,000 reimbursed to SNSW officials who have attended a minimum of 15 sessions across the past 12 months.

Since the Sydney Open in May 2024, there have been 2,030 sessions worked across 85 sessions by technical officials at SNSW events: another testament to the commitment of our dedicated volunteers. Further, the NSW/ACT also continues to be the highest represented state or territory at national meets:

- » 2024 Short Course Nationals 12 officials
- » 2024 Open Water Nationals 5 officials
- » 2024 Junior Pan Pacific Championships 11 officials
- » 2025 Age Nationals 12 officials
- » 2025 Open Nationals 13 officials

Two of our highly experienced officials represented NSW on the biggest stage – Faye Lewis at the Paris Olympics, and Murray Smith at the 2024 World Championships in Budapest. Additionally, Murray also attended the Para World Series event in Fuji from April 10-12. We congratulate Faye and Murray on these achievements.

From a development perspective, nine officials became accredited Referees and a further four have completed their exams and are awaiting assessment. Nick Keith, Jeff Thompson, Jacqui Currey, Kayleen Murphy, and Brett Patrick all reached Referee Level 3, and three more officials are ready to be assessed at the same level thanks to successful pre-assessments at Senior State Age in December.

SNSW staff member and NSW TO Belinda Havron was accepted into the Australian Sports Commission Women's Mentor Program. This course is designed to drive gender equity and positive sport experiences for girls and women in sport. We are proud of Belinda and look forward to utilising the experience gained to create increasingly positive sporting experiences for female technical officials in NSW.

EVOLVING OUR EVENTS

SNSW continues to reshape and elevate state events, with the formal introduction of structured post-event feedback. Coaches, swimmers, and parents were invited to share their experiences following each major competition, providing valuable insights.



This feedback is now an integral part of the Competitions Committee's processes, directly informing decision-making and driving continual improvement. By actively listening to our community, SNSW is delivering more inclusive, responsive, and athlete-focused competitions that reflect the needs of all members.

We extend our sincere thanks to the Competitions Committee for their dedication, hard work, and vision throughout the year. Their efforts are pivotal in shaping the future of our sport and ensuring our events continue to evolve in meaningful ways.

In 2024/25, over 16,000 swimmers participated in SNSW events—a significant increase from the previous year. This growth also contributed to a 3% rise in total event entries, a remarkable outcome in the face of ongoing economic challenges.

The 2024/25 Senior State Age Championships was our largest and most successful State Age event to date. Over seven days of fast-paced and high-calibre racing, more than 1,400 swimmers delivered upwards of 4,850 individual swims. The atmosphere was electric, and the level of competition showcased the depth of talent within our swimming community. Post event feedback was overwhelmingly positive, reinforcing the event's standing as one of the premier age-based competitions in the country.

As part of the Country Championships and in celebration of NAIDOC Week, SNSW proudly hosted the NAIDOC Week Relays for the third consecutive year. This special event brought together 21 Indigenous athletes from across NSW to compete in two relay races: the 4x50m Freestyle Relay and the 4x50m Medley Relay. Six teams—up from five last

year—competed under names inspired by water animals, drawn from the Dharug Language, the traditional language of the Wann-gal People on whose land the championships were held.

SNSW hosted eight Multi Class Classification Days during the 2024/25 season. These were held alongside SNSW meets at the Sydney Olympic Park Aquatic Centre (SOPAC), providing greater access and visibility for Multi Class athletes. SNSW continues to work closely with Swimming Australia to expand pathways and opportunities for Multi Class participation across all levels of the sport.



CREATE PROGRAMS THAT DRIVE PARTICIPATION IN SWIMMING

Participation Strategy

The SNSW Strategic Plan focuses on strengthening the three key pillars on which our sport is built: Participation, Performance, and Partnerships. In 2025, SNSW established the Participation Committee to support Management with the development of a statewide Participation Strategy.

In September 2024, SNSW surveyed clubs to seek data to inform the development of the strategy and over 103 clubs provided responses that will shape our future. This information was presented to the Committee for consideration and discussion.

Our vision for the strategy is to create a future where everyone, regardless of background or ability can find connection and enjoyment through swimming. By working together, we will create vibrant, safe and engaging experiences that inspire lifelong involvement and enrich our communities beyond the pool.

SNSW participation objectives are to:

- 1. Drive swimming participation growth by attracting and retaining members
- 2. Reimagine how participation is delivered in our sport
- 3. Deliver outcomes well beyond the pool by enriching the community through connection and social interaction

- 4. Align and grow our community of volunteers to support the delivery of our sport
- 5. Ensure everyone has a place in our sport by creating safe, welcoming and fun environments and experiences.

These objectives will be advanced through collaborative partnerships and a willingness to embrace innovation and technology. The strategy remains in a draft format with Swimming Australia in the final stages of developing the National Participation Strategy aligned with the Australian Sports Commissions *Play Well* strategy. In consultation with the Committee, SNSW made the decision to cease further progress on the NSW strategy until a national strategy is completed to ensure alignment. Management continues to work with Swimming Australia and it is expected that a national strategy will be finalised in mid-2025.

Whilst the national strategy is being finalised, the Committee took a project based approach and supported Management to deliver several new participation initiatives including:

- Strengthening our awareness and connection to our Indigenous members through the 2025 Country Regional Championships
- » Creating and circulating a statewide participation survey that provided valuable insights that will shape our thinking
- Sestablishing the Regional Scholarship Program providing regional coaches, athletes and technical officials with opportunities to apply for funding to support their travel to NSW.

We thank Uncle Rex and Committee Member Alision Stewart for their leadership and contribution to supporting SNSW to recognise our Indigenous heritage in a meaningful way.



In 2025, the New South Wales Institute of Sport (NSWIS) launched a Para Unit that will be pivotal in supporting the development and high performance success of para athletes across a range of sports within NSW. The Para Unit will collaborate with national sporting organisations, including Swimming Australia and Paralympics Australia, to ensure aligned athlete pathways and targeted support for emerging and elite para athletes. In partnership with NSWIS, SNSW will develop the foundations of the Swimming Para Unit with an initial focus on growing the pool of NSW classifiers to provide increased opportunities for participation in our sport.

A key focus of the Para Unit will be to deliver an inclusive and integrated environment, where para-athletes are provided with equitable access to resources and opportunities comparable to their able-bodied peers. This exciting opportunity will see SNSW and NSWIS partner to deliver new opportunities within our Paralympic Pathway Program from grassroots to podium performances.





Performance Centre Clinics

SNSW strengthened engagement between Performance Centres and the broader swimming community through the delivery of Performance Clinics. These clinics were designed to cater for athletes that qualify for the NSW Metropolitan or Country Championships, and invitations were extended to local coaches to provide important development opportunities. In total, 12 clinics were held with over 700 swimmers participating in the new initiative across regional and metro Areas.

Feedback from participants was outstanding and the 2025/26 program will feature Olympic and Paralympic athletes to inspire the next generation of swimmers.

JX Clinics

The national Junior Excellence (JX) program, sponsored by Pho3nix, recognises the performances of swimmers aged 9 – 13 to encourage and inspire the next generation of competitive swimmers. States and Territories are required to facilitate two clinics every 12 months. Such was the success of the first two clinics, SNSW requested to deliver a third within regional NSW.

Across the three clinics, 333 young swimmers dived into skills, drills, dryland sessions, and interactive talks with Olympic and Paralympic and international athletes including Timothy Hodge, Ellie Cole AM, Jasmine Greenwood, Meg Bailey, Se-Bom Lee, Matthew Wilson and Abbey Webb. The feedback has been overwhelmingly positive, and thanks to Swimming Australia's ongoing partnership with Pho3nix, SNSW will seek to deliver more clinics throughout the year ahead.

In addition to the SNSW JX clinics, Swimming Australia hosted an additional clinic in Coffs Harbour - a testament both to the success of the NSW clinics, as well as a strong ratio of JX swimmers in NSW.

Club Support

SNSW Club Support Officers continued to support clubs to drive participation in our sport. Initiatives included regional road shows to visit regional clubs as well as engagement at SNSW events including Area Championships, SNSW Country Championships, Senior State Age, and Country Regional events. REGIONAL GROWTH

Drive swimming participation and growth in regional NSW

Engaging and Empowering Regional Coaches

SNSW Regional Coaching Director Chris Myers continued his outstanding work engaging with and supporting regional coaches across New South Wales. Chris travelled extensively throughout the state, working side by side with local coaches in clubs from Coffs Harbour to Macksville, observing sessions, sharing technical insights, and helping strengthen coaching programs.

His visits to 65 programs in the last 12 months highlighted and supported the legacy of icons like Ruth Everuss in Maclean and spotlighted the commitment of emerging coaches such as Billy Nicholson (Port Macquarie), Dean Laurence & Daniel Bannerman (Coffs Harbour), and Renee Pickvance (Macksville).

Chris also led more than 30 Area Development Clinics involving over 600 swimmers and dozens of coaches, delivering hands-on coaching support and facilitating high-impact learning opportunities for athletes and coaches.

At the Regional Development Camp at the AIS, Chris mentored talented young swimmers alongside regional coaches, fostering skills and team connections. Chris's work continues to strengthen the coaching community in regional NSW, ensuring local coaches are empowered, inspired, and connected to the broader swimming network across the state

Country Regionals

The 2025 NSW Country Regional Events were a weekend of incredible swimming performances, community engagement, and team spirit. Held across three locations—Taree, Griffith, and Gulgong—this year's events brought together over 2,000 swimmers, spectators, and volunteers from across New South Wales. SNSW would like to thank the local councils, Areas and clubs that made this event possible.

Event banners and medals, featured artwork by Indigenous artist Rex Winston, adding a meaningful cultural dimension to the event. Winston's "Water Dreaming" design celebrates the beauty and significance of rain, embodying renewal and connection to nature. The rippling patterns of the artwork reflect the cycles of water, underscoring its sacredness in Indigenous culture.

Despite bad weather, the Manning Aquatic Leisure Centre in Taree welcomed over 500 competitors, making it the largest of the three events. Swimmers and coaches adapted to the rainy conditions with determination and positivity.

Mayor Jeremy Miller welcomed swimmers, families, and officials and emphasised how wonderful it was to bring such a significant event to the local area. The pool looked fantastic dressed in the Taree Torpedoes Club colours, with black and gold lane ropes adding a vibrant touch.



At the Griffith Regional Aquatic & Leisure Centre, 346 swimmers gathered to compete. The event began with a "Ready, Set, Race" Clinic on Friday afternoon, led by SNSW Regional Coaching Director Chris Myers, setting the tone for an engaging and successful weekend.

Deputy Mayor Anne Napoli and SNSW CEO Kirsten Thomson OLY opened the event welcoming swimmers, coaches, officials and spectators followed by an Acknowledgement Country by swimmer Lane Stewart.

The Gulgong Country Regionals, co-hosted by Gulgong Swim Club, Mudgee Swim Club, and Mudgee Marlins Swim Club, were held at the Gulgong Swimming Pool and welcomed 259 competing swimmers. Local enthusiasm was contagious as the pool buzzed with activity. The event was officially opened by local Mudgee resident Ken Sutcliffe OAM, adding a special touch to the weekend.

The 2025 NSW Country Regionals showcased exceptional swimming talent and highlighted the importance of community, cultural recognition, and teamwork. Each event's success was made possible by the collective efforts of officials, local swim clubs, volunteers, parents, and local councils. The inclusion of Indigenous cultural elements added depth and meaning, reminding all participants of the land's rich heritage.

Thank you to everyone who participated and supported these incredible events. We look forward to continuing the tradition of excellence and camaraderie at next year's Country Regionals.

The SNSW Country Championships was a remarkable event, featuring 1,167 swimmers from 99 clubs. It was great to see SOPAC buzzing with energy, filled with enthusiastic swimmers and coaches. The meet provided a valuable opportunity for regional participants to compete, grow, and be inspired in their swimming journeys. It was also a chance for swimmers and coaches to proudly represent their clubs with passion.

A highlight of this year's Country SC Championships was the return of the Parade of Clubs, presented in a new and exciting digital format. In its debut year, an enthusiastic group of 30 clubs took part, showcasing some creative and vibrant team photos. We can't wait to see how this digital parade continues to grow and evolve in the years to come.

Development Program

Following the 2023/24 season, SNSW sought feedback from Areas regarding Area Development. The feedback led to SNSW implementing a statewide approach to development for 2024/25.

The Area Development Program's purpose is to bring together swimmers across NSW in a social and non-competitive environment to encourage participation in swimming. Further, these opportunities aimed to enhance skill acquisition and stroke development and provided coaches with development opportunities.

Chris Myers, SNSW Regional Coaching Director, facilitated two clinics per weekend, across the eight regional Areas. The feedback from attendees and coaches was overwhelmingly positive, and many expressed a desire to participate in the program in subsequent years.

Swim Sampler Weekend

SNSW partnered with the Southern Inland Swimming Association (SISA) to deliver the inaugural *Swim Sampler Weekend* in Wagga Wagga, a celebration of participation and performance in regional NSW. The weekend featured four exciting events: *School Splash*, *Club Splash*, the *Pho3nix JX Clinic*, and the *SNSW Performance Centre Clinic*, attracting over 170 participants of all abilities.

The School Splash welcomed over 80 students in a fun, team-based format aimed at building water confidence, while the Club Splash supported local clubs by providing a fast, fun introduction to club-level racing. Swimmers had the chance to train with Olympian Matthew Wilson and Southern Performance Centre Head Coach David Proud during the Pho3nix JX and Performance Centre clinics, offering both inspiration and high performance guidance.

With strong community engagement, enthusiastic feedback, and valuable exposure to elite coaching in a regional setting, the *Swim Sampler Weekend* demonstrated the power of innovative event formats in driving participation and supporting regional development. The initiative will continue to be a key part of our strategy to grow the sport in all corners of NSW.

Regional Classification & Race Pilot Event

Swimming North Coast held its annual Multi Class/Para Swimming Day at South Grafton, an event that's been running since 2014 to showcase opportunities for young swimmers with disabilities and their families. For the first time, SNSW arranged on-site classification opportunities as a Pilot Project, allowing local swimmers to be classified without travelling to Sydney. This is the first classification day to be held in regional NSW.

Michael Anderson, Para Pathways Manager for Swimming Australia and former Paralympic swimmer, provided insights into the classification process. Swimmers engaged in pool activities led by Head Coach Michael Abel of Stroud Seals Swim Club, with the support of assistant coaches Helen Phipps and Karina Plunkett, who guided the younger, more nervous participants. The day, which saw record attendance, concluded with a fun mini swim meet and certificates presented by Michael Anderson.

SNSW is leading the country in this space, and we look forward to more exciting initiatives in 2025.

ENGAGE REGIONAL COACHES

Engaging and Empowering Regional Coaches

SNSW's commitment to regional coaching development continues to thrive under the leadership of Regional Coaching Director, Chris Myers. In 2024, Chris built upon his already exceptional work with regional coaches, highlighted by his annual Regional Roadshow. This initiative included more than 65 club programs across regional New South Wales.



Chris spent time on-deck with local coaches, observing training sessions, sharing technical insights, and helping refine program structures to align with contemporary coaching best practices. At Maclean, he paid tribute to the legacy of swimming coaching icon Ruth Everuss, while in other locations, he shone a spotlight on the current generation of dedicated coaches including Billy Nicholson (Port Macquarie), Dean Laurence and Daniel Bannerman (Coffs Harbour), and Renee Pickvance (Macksville), whose tireless work continues to drive athlete success.

SNSW also delivered over 30 Area Development Clinics across the state. These clinics brought together more than 600 regional swimmers and dozens of coaches, creating rich environments for technical learning and performance development. These events are essential to SNSW's development pathway, ensuring that young swimmers and their coaches—regardless of postcode—have access to elite level insights and opportunities.

A Regional Development Camp was held at the Australian Institute of Sport (AIS), to guide some of the state's most promising swimmers. The camp fostered skill development, team cohesion and a deeper connection to the broader swimming community.

LINK REGIONAL ATHLETES WITH PERFORMANCE CENTRES

SNSW progressed the concept of Performance Centres delivering value beyond the clubs and athletes that train within the centres by providing opportunities for regional athletes to attend these environments for training and clinics. By invitation, identified regional athletes and coaches attended Performance Centres for sessions and camps as part of their preparation of the 2024 Australian Age and Open Championships and the 2024 Olympic and Paralympic trials providing a vital link and development opportunity for both the athletes and coaches.





Management continues to work with information technology provider Datcom to improve our IT systems.

SNSW continued to work with Swimming Australia and other States to improve the national Swim Central platform to ease the burden on volunteers and supported Swimming Australia with the release of Swim Finder, a tool which enables newcomers to the sport an easy way to locate pools, clubs and coaches in their area.

TIMING INNOVATION

After supporting the development of Olly Timing last season, SNSW utilised the system as the backup to touchpad electronic timing at state events. This advancement has eliminated the need for club timekeepers, significantly streamlining event operations and receiving positive feedback from clubs and parents across the state.

Alongside the use of Olly Timing, SNSW continues to work with SOPAC on the installation of Hawk-Eye video officiating—a system used by World Aquatics at major international events. SNSW acknowledges the significant investment by the NSW Government to fund the installation of world class technology at SOPAC.

SNSW also continued to partner with the NSW Government

to seek increased investment in our sport and to improve opportunities for NSW to host national and international events. The Sydney Olympic Park Aquatic Centre provides a home for the majority of SNSW meets and this relationship is vital to ensuring our sport can afford to host meets at this Olympic / Paralympic legacy venue.

SWIM SHOP SUCCESS

By harnessing technology, the Swim Shop powered an exceptional result in 2024/25, using digital tools and social advertising to better connect with members and reach a wider audience online. This tech-driven approach delivered a remarkable 272% increase in online sales, helping lift total store revenue by 8.4% and generating an \$84,185 increase on the previous year.

Behind the scenes, the store team did an outstanding job leveraging store data systems to continually review and refine the product mix, ensuring the right products were available at the right times throughout the year. In a retail environment challenged by rising cost-of-living pressures, this achievement stands out as an extraordinary success and a testament to the smart use of technology, data, and team expertise to drive growth and deliver value to the SNSW community.

2024 PARIS OLYMPIC AND PARALYMPIC GAMES

2024 Olympic Games

Five NSW swimmers brought home two gold and a silver from the Paris 2024 Olympic Games. Competing at the La Défense Arena, they proudly represented Australia, and NSW, amidst packed stands and intense competition.

Congratulations to Adam Kable (NSWIS Hub) who was selected to the Australian Olympic Swim Team as a coach and to Mikayla Patterson and Shannon Rollason for placing athletes on the Olympic Team.

Four of the five coaches who placed athletes on the Australian Olympic Team were based at SNSW Performance Centre's demonstrating the high performance environments that have been created to enable athlete and coaches success at the international level.

Olivia Wunsch, at her first Olympics, and Bronte Campbell, at her fourth, secured gold in the Women's 4x100m Freestyle Relay. The relay team, which also featured Mollie O'Callaghan, Shayna Jack, Meg Harris, and Emma McKeon, dominated the event with their combined efforts.

William Yang contributed to Australia's silver medal in the Men's 4x100m Freestyle Relay. At his first Olympics, it was a dream start. William also swam in the Men's 100m Freestyle individual semi-final after a call-up as the first reserve, finishing 15th with a time of 48.42.

Se-Bom Lee, who competed in Tokyo in the 400m Individual Medley, stepped into the Men's 200m Backstroke at trials for Paris. Bradley Woodward, at his first Games, competed in both the Men's 100m and 200m Backstroke.

We are incredibly proud of these athletes and coaches who represented the Mighty Blues in one of the most competitive Games on record.



2024 Paralympic Games

The 2024 Paralympic Games saw impressive performances from five NSW swimmers, who brought home two gold and two silver medals.

Misha Payne (ACU Blacktown) and Marty Roberts (Australian Paralympic Hub – Canberra) were selected to the Australian Paralympic Swim Team as coaches. Congratulations to Laura Brindley (Cruiz) and Hannah Watkins (KPD) for placing athletes on the Paralympic Team.

Timothy Hodge, a three-time Paralympian, won two gold medals, including a Paralympic record in the Men's 200m Individual Medley SM9, and another gold in the Mixed 4x100m Medley Relay. Timothy capped off his stacked campaign with a silver medal in the Men's 100m Butterfly S9.

Chloe Osborn, making her Paralympic debut had a successful campaign, delivering a silver medal in the Mixed 4x100m Freestyle Relay 34 points with teammates Alexa Leary, Rowan Crothers and Callum Simpson.

Paris 2024 was Jesse Aungles' third Paralympic Games and won his maiden Paralympic medal in the Paris La Defense Arena pool. Jesse went straight to the top with gold in the Mixed 4x100m Medley Relay 34pts alongside teammates Timothy Hodge, Emily Beecroft, Alexa Leary and heat swimmers Callum Simpson and Keira Stephens.

Ella Jones, making her Paralympic debut in Paris, delivered a strong result with sixth overall in the Women's 400m Freestyle S8 event.

Jasmine Greenwood, a two-time Paralympian competed in four events including Women' 50m Freestyle S10 (8th), Women's 100m Backstroke S10 (6th), Women's 100m Butterfly S10 (4th) and Women's 200m Individual Medley SM10 (6th).

Timothy Hodge was named the Paralympic Program Swimmer of the Year, whilst Misha Payne was named Coach of the Year at the Swimming Australia Awards.

These athletes and coaches performed brilliantly in Paris, and we are proud of their achievements.

WORLD CLASS PATHWAYS

The 2024/25 SNSW Performance Pathway Program provided important opportunities to developing athletes across NSW. The strengthened program was established following a review that included input from SCTA NSW, NSWIS and Swimming Australia. The achievements and activities

The SNSW Touring Team, led by world class head coach Shannon Rollason, won a total of 12 medals (4 gold, 5 silver, 3 bronze) and had a high conversion rate from heats to finals of 85%. These results emphasise the team's focus on racing and making finals.

It is vital that SNSW provides opportunities for our athletes to strive towards and international tours will be an important cornerstone of our Performance & Pathways Strategy. SNSW thanks SCTA NSW for providing funding for the scholarship coaching position for the Japan Open Tour.

South Australian Open Touring Team (National and NSW Flippers)

Thirteen swimmers and 4 coaches made up the NSW Team that competed at the 2025 South Australian Open Championships.

The team won 13 gold, 9 silver, and 6 bronze - a total of 28 medals.

The NSW swimmers displayed outstanding determination over the three days of competition in challenging conditions, gaining valuable experiences and insights. Thank you to the team coaches, Angelo Basalo (Warringah), Michaela Pattinson (Carlile), and Justin Rothwell (Manly), whose exceptional leadership and teamwork greatly contributed to the swimmers' achievements.

Special thanks to Swimming Australia's Leigh Nugent and Gary Barclay for their continued support of our NSW swimmers and coaches.

NSW Futures Squad - LA28 Dreaming Camp

A cohort of swimmers descended upon the AIS for a joint camp between SNSW and Swimming Queensland. A total of 45 athletes, 3 managers, 3 sport scientists, and 10 coaches attended the SNSW LA28 Dreaming Camp.

Eleven swim sessions were held during the week long camp, supplemented with two gym sessions. The swimmers were divided in six groups to enable a stroke specific focus for the swim sessions.

NSW Open Water Squad

Led by world class Head Coach Chris Nesbit (Carlile) and supported by Nic Dobson (Knox Pymble) and Alyce Wierzbicki (SLC Aquadot) swimmers experienced four days of valuable lessons to develop as Open Water athletes.

The camp at the Sunshine Coast provided athletes with opportunities through structured training sessions to sharpen their skills, prepare for the unexpected, and build confidence in Open Water. It also allowed athletes to build relationships and trust in each other and feel a sense of camaraderie with likeminded athletes.

Athletes completed four pool sessions, as well as session at the Oz Ski Resort in preparation for the QLD State OW Championships held on Saturday 12th October. The team's results included three gold, three silver and three bronze medals.

Para Futures Squad

The SNSW Para Futures Squad showcased their determination, talent, and teamwork during a two-day camp at Cranbrook Aquatic Centre. With a packed schedule of testing, skills development, and expert guidance, the camp proved to be a resounding success.

This included a nutrition presentation by Sally Walker (Dietician for the Australian Olympic Team at Tokyo 2020), which sparked lively discussions among swimmers and parents alike. Topics ranged from optimising food choices for training and competition to practical strategies for parental support, reinforcing the holistic approach to athlete development.

Coaches Gavin Stewart (Aquablitz), Lachlan Vane Tempest (St George), Michael Creighton (Wenona), Debby Tattoli (KPD), Kerry Saunders (Hunter), Pascal Giraud (Maroubra),

and Sandi Edwards (Aqua Culture Swim) provided invaluable guidance, ensuring each athlete received tailored support.

The camp underscored the potential of the SNSW Para Futures Squad as they work towards excellence. From rigorous testing to skill refinement, every aspect of the camp was designed to empower athletes and foster a sense of camaraderie.

SNSW Development Programs

The Regional Development Camp was held at the AIS in Canberra, where 20 promising young swimmers (10 male and 10 female aged 14 to 16) trained intensively over four days. Selected from age nationals and the Talent ID program, these athletes were guided by experienced coaches to refine their stroke techniques and competitive skills.

The camp was led by coaches Chris Myers (SNSW), Laura Brindley (Cruize), Kerry Saunders (Hunter), Brandon Lawrence (Kinross), and Shannon Comford (Casino), who focused on all strokes and key swim skills.

The Junior Development Program, which included 12 metro-based and 12 regionally based swimmers, were invited to take part in a clinic, held at SOPAC during the NSW Sydney Open on Friday 1st May. Swimmers were invited to the clinic after achieving a top three placing in the 11/12 year girls and 12/13 year boys age groups at either Junior Metro or Country Championships in the Individual Medley events. Under the guidance of Coaching Director Jon Shaw and Regional Coaching Director Chris Myers, six coaches from NSW led the swimmers through a skills-focused clinic on each stroke. SNSW PERFORMANCE PATHWAYS STRATEGY 2025+

SNSW embarked on an ambitious goal of developing a new Performance Pathways Strategy that would set NSW on a path towards 2028 and beyond. The strategy was developed through engagement with key stakeholders including Swimming Australia, NSWIS and SCTA NSW and SNSW Performance Centre Head Coaches during a two-day workshop to delve into what success looks like at the 2028 and 2032 Olympic and Paralympic Games.

The outcome is a transformative SNSW Performance Pathways Strategy and a 2025 Performance Pathways Program that will deliver:

- » An increased number of Performance Pathway Squads with the addition of an NSW Open Squad
- » An additional Touring Team for 2025 (3 touring teams up from 2 in 2024)
- » Higher athlete numbers selected within the squads
- » Addition of a training camp at the AIS for the Para Futures Squad
- » Engagement of a Physical Preparation Lead to support identified club programs and pathways athletes
- » An integrated pathway achieved via combined training days for adjacent squads annually (e.g. Open Squad with Futures Squad)

Thanks to NSWIS, ACTAS, and Swimming Australia for their ongoing support of swimming in NSW and to our Performance Centre coaches their willingness to lead the broader swimming strategy for our state and the ACT.

NSW positioned as a national ecosystem leader for high performance programs

SNSW Performance Centres are high performance training environments, led by nationally and internationally recognised coaches and established to help talented athletes from across NSW develop to the highest levels of the sport.

The success of athletes and coaches at the 2024 Olympic and Paralympic Games are a testament to the strong performance focused environments developed in NSW with our key partners. These environments complement the strong NSW club system that, together, will drive NSW towards our ambitious vision.

SNSW operated the following Performance Centres during the reporting period:

- SOPAC Performance Centre (in partnership with NSWIS and SOPAC)
- » ACT Performance Centre (in partnership with ACTAS)
- » NUsport Performance Centre (in partnership with the University of Newcastle and NSWIS)
- Southern Performance Centre (in partnership with the Sutherland Shire Council and NSWIS)

Since its launch in early 2024, the Southern Performance Centre has seen a rapid shift in performance, with total squad enrollments reaching 200 (150 in April 2024) and total learn to swim enrollments 2,392 (1,800 in April 2024). The Performance Centre also saw the numbers of National Age Qualifiers grow to 15 athletes in 2025, from 1 athlete in 2024.

The Nusport Performance Centre based at The Forum, University of Newcastle continued to innovate and leverage the resources from the partnership with University of Newcastle. The Performance Centre, driven by Head Coach Sander Ganzevles collaborated with Dr Colin Sanctuary (Lecturer and Researcher EXSS – Newcastle University) to deliver 9 student placement opportunities with the swim program:

- » 4 x Undergraduate students within Exercise and Sport Science
- » 1 x Undergraduate student from Physiology
- » 4 x Undergraduate students from Nutrition

Sander and Colin continued the collaboration working together with the Exercise and Sport Science department at the University of Newcastle to begin a Research study with an Honors student with a scientific publication expected in 2025/26.

Four of the five coaches who placed athletes on the Australian Olympic Team were based at SNSW Performance Centre's demonstrating the high performance environments that have been created to enable athlete and coaches success at the international level.

The SOPAC Performance Centre continued its impressive history to placing athletes and coaches on the Olympic Team following a breakout Australian Trials in Brisbane in 2024. The program strengthened its Daily Performance Environment during the last 12 months, enabling Will Yang, Se Bom Lee, Bradley Woodward and Adam Kable (NSWIS Hub Head Coach) securing their spot on the coveted Australian Olympic Team.

At the 2024 Paris Olympic Games, Will Yang delivered a strong performance securing a Silver medal as part of the Men's 4x100m Freestyle Relay team.

The SOPAC Performance Centre also delivered a strong performance at the 2024 Australian Age Championships, securing 6th place in the Club Championship point score.

The ACT Performance Centre also has strong 2024 Australian Trials and 2024 Paris Olympic Games. Led by Shannon Rollason (ACT Performance Centre Head Coach), Bronte Campbell stormed to her 4th Olympic Games by securing her spot on the Women's 4x100m Freestyle Relay after placing 4th at Trials.

At the 2024 Paris Olympic Games, Bronte Campbell delivered a strong performance securing Gold as part of the Women's 4x100m Freestyle Relay team.

The ACT Performance Centre continued to strengthen its Daily Performance Environment with the addition of Laura Brindley as Assistant Coach - ACT Performance Centre. The increased coaching capacity and expertise further drives the quality of the program to deliver a sustainable performance pathway heading towards LA2028 and Brisbane 2032.

In 2024/25 Sydney Uni Sport, NSWIS and SNSW joined forces to establish a Performance Centre as part of an ambitious plan to have the state's swimmers on top of the podium in front of a home crowd at the Brisbane 2032 Olympic and Paralympic Games.

The Sydney University Swimming Performance Centre will aim to elevate the performance of talented student athletes from across New South Wales, providing clear pathways for swimmers who wish to pursue their academic and athletic goals to the highest level. Eligible student athletes will be supported by a combination of Sydney Uni Sport's Elite Athlete Scholarship Program and NSWIS scholarships.

Recruitment for a suitable head coach for this program remains ongoing.

SNSW / NSWIS Towards 32

In 2024, SNSW and NSWIS (supported by SCTA NSW) launched a Towards 32 Female Athlete & Coach Initiative to drive the progression of NSW female athletes and their coaches. Three, two-day camps were delivered with the top 12 female athletes in the state and their coaches. The top six female coaches in NSW were also invited to participate in the event led by NSWIS Hub - SOPAC Head Coach Adam Kable.

Highlights included an athlete dinner with 2012 and 2016 Olympian Jessica Ashwood and the female athletes, and a coach dinner led by NSWIS Coach Development Lead and former GWS Giants Coaching Director Alan McConnell who facilitated conversations between the coaches and NSWIS Olympic Diving Coach Chava Sobrino.

NUSPORT AT THE FORUM An important part of the SNSW Strategic Plan is for staff to feel empowered within their roles and to have the capability and support to deliver against organisational objectives. In 2024/25, SNSW continued staff excellence planning including Personal Excellence Plans and Professional Development Plans to support staff to achieve outcomes and progress their capability.

Development opportunities for staff included on the job learning and mentoring with senior staff and coaches partnering with junior team members on key projects and initiatives, attendance at industry seminars and workshops and webinar opportunities provided by Sport NSW, Sport Integrity Australia and the Office of Sport.

SNSW provided all staff with first aid and CPR training and provided WHS Committee Members with associated courses to meet legislative requirements.

SNSW Directors were encouraged to undertake educational opportunities provided by the Australian Sports Commission, including four online courses to support best practice governance.

COACH DEVELOPMENT FRAMEWORK

Built on three foundational pillars, coach development, coach education and coach wellbeing & engagement, the SNSW Coach Development Framework (CDF) guided progression opportunities for NSW coaches.

The SNSW coaching team of Jon Shaw, Chris Myers and Greg Salter worked across NSW in partnership with SCTA NSW to support the development of coaches via delivery of the SNSW Coach Development Framework.

Over the course of the year there were up to 50 program visits completed in the Metropolitan area, and up to 65 regional programs.

DEVELOP AND DELIVER SAFE SPORTING ENVIRONMENTS

SNSW continues to be recognised as a leading State Sporting Organisation in relation to the ongoing

implementation of safe sporting initiatives. In 2024/25, SNSW completed the Office of the Children's Guardian Child Safe Assessment, an important step to improve safe practices in our sport.

The results of this Assessment have been utilised to build a Child Safe Action Plan that will be placed on the SNSW website in 2025/26 and reported against within future Annual Reports. Member welfare matters were addressed in alignment with the National Integrity Framework and SNSW worked closely with the Swimming Australia Integrity Unit to strengthen our practices and educate our members.

SNSW promoted the following education opportunities to members:

- » Transporting and travelling with Children and Young People – Sport Integrity Australia
- » Regional Child Safe Workshops Office of Children's Guardian
- » De-escalation and Occupational Violence and Aggression training – Office of Sport
- » Empowering an Athlete's Mental Toolkit webinar Office of Sport's Future Champions Masterclass

SNSW supported National Integrity Month in November with Swimming Australia, raising awareness of the resources available to support clubs to provide safe sporting environments.

SNSW engaged the Black Dog Institute to deliver Mental Health Training via online self-paced education sessions for SNSW staff. These sessions focused on:

- » how to spot the early warning signs of mental ill-health
- » how to have conversations at work about mental health
- » your work health and safety rights and responsibilities
- » steps you can take for your own self-care or to support others
- » where to go for more support.

National Integrity Committee

Swimming Australia undertook an audit of its integrity function through the support of Sport Integrity Australia's continuous improvement program. The review resulted in the establishment of a new National Integrity Committee that facilitates cooperation, collaboration and information flow between Swimming Australia and Member Organisations relating to children and young people and member protection. SNSW is represented on the Committee that meets quarterly.

SNSW Touring Teams travelled to South Australia and Japan in 2024 delivering best practice environments following the implementation of revised Touring Team and Camp Guidelines aligned to the National Integrity Framework and the NSW Child Safe Standards.

ROLES AND RESPONSIBILITIES OF THE COMMITTEE

The Audit and Risk Committee is established under Clause 30.7 of the Constitution of Swimming NSW (the Company) with the Charter set out in By Law 18. It is a standing committee of the Board without any executive function. The Committee assists the Board with the Company's governance and the exercising of due diligence throughout its operations while supporting the Board in the development of Board policy and monitoring the activity of the Company within the scope of its remit. The Committee also acts as a support to the Board in its strategic decision-making process by the review and provision of advice about:

- » the integrity and reliability of financial, budgeting and audit reporting processes (including the application of appropriate accounting policies)
- » the adoption of risk management strategies to manage/ monitor both current and emerging financial and operational risks
- * the investment of the Company's surplus funds, and the performance of those investments and the investment manager
- » compliance with the Company's Work Health and Safety policies and practices, and relevant legislation
- * the protection of the Company's assets the effectiveness of the Company's system of internal controls
- **»** the independence, objectivity and effectiveness of the annual audit process.

MEMBERSHIP OF THE COMMITTEE

The Committee consists of two directors of the Company appointed by the Board (one of whom is to be Chair) and four independent persons also appointed by the Board. These independent appointees collectively possess appropriate financial and business skills and have a knowledge of the sport. NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 MARCH 2025

1. CORPORATE INFORMATION

The consolidated financial report of Swimming New South Wales Limited and its controlled entities (the consolidated entity) for the year ended 31 March 2025 was authorised for issue in accordance with a resolution of the Directors on 27 May 2025.

Swimming New South Wales Limited (the Company) is a company limited by guarantee and without share capital. It is incorporated and domiciled in Australia.

The nature of the operations and principal activities of the Company are described in the Directors' Report.

2. SUMMARY OF MATERIAL ACCOUNTING POLICY INFORMATION

(a) Basis of preparation

The consolidated financial report is a general purpose financial report, which has been prepared in compliance with the requirements of the Corporations Act 2001, Australian Accounting Standards – Simplified Disclosures and other authoritative pronouncements of the Australian Accounting Standards Board. The Group is a not-for-profit entity for the purposes of preparing this consolidated financial report. The consolidated financial report has been prepared on a historical cost basis, except for financial assets designated at fair value through OCI which have been measured at fair value.

The consolidated financial report is presented in Australian dollars.

The consolidated financial report has been prepared on a going concern basis, which contemplates continuity of normal business activities and realisation of assets and settlement of liabilities in the ordinary course of business.

Management have provided a detailed cash flow forecast to support the going concern assumption to the Directors. The Group operated at a profit in the financial year ended 31 March 2025 and the cash flow forecast supports the ability of the Group to continue as a going concern and pay its liabilities as and when they fall due.

The consolidated financial report does not include any adjustments relating to the recoverability and classification of recorded asset amounts or to the amounts and classification of liabilities that might be necessary should the entity not continue as a going concern.

(b) Statement of compliance

The consolidated entity is a not-for-profit entity which is not publicly accountable. Therefore the consolidated financial report of the consolidated entity is a tier two general purpose financial report which has been prepared in accordance with Australian Accounting Standards – Simplified Disclosures (including Australian interpretations) adopted by the Australian Accounting Standards Board (AASB) and the Corporations Act 2001.

The consolidated financial report complies with Australian Accounting Standards. Australian Accounting Standards contain requirements specific to not-for profit entities, including Standards AASB 116 Property, Plant and Equipment, AASB 136 Impairment of Assets and AASB 1004 Contributions.

(c) Basis of consolidation

For the year ended 31 March 2025, the consolidated financial report incorporates the financial statements of the Company and the entities controlled by the Company, being New South Wales Swimming Nominees Pty Ltd, NSW Swimming Foundation Trust and Swimming NSW Aquatic Management Pty Ltd.

Control is achieved where the Company has the power to govern the financial and operating policies of an entity so as to obtain benefits from its activities. The results of the subsidiaries included in the consolidated statement of

comprehensive income are from the effective date of acquisition. All intra-group transactions, balances, income and expenses are eliminated in full on consolidation. In the separate financial statements of the Company, all intragroup transactions are generally accounted for by reference to the existing book value of the items.

(d) Changes in accounting policy, disclosures, standards and interpretations

New and amended standards and interpretations

The accounting policies adopted are consistent with those of the previous financial year except for the adoption of new standards and interpretations effective as of 1 April 2024.

The new and amended Australian Accounting Standards and interpretations that apply for the first time in 2025 do not materially impact the consolidated financial statements of the Group.

Accounting Standards and Interpretations issued but not yet effective

Certain Australian Accounting Standards and interpretations have recently been issued or amended but are not yet effective and have not been adopted by the Company for the annual reporting year ended 31 March 2025. The Company intends to adopt the new or amended standards or interpretations when they become effective.

(e) Cash and cash equivalents

Cash and short term deposits in the balance sheet comprise cash at bank and on hand and short term deposits with an original maturity of three months or less.

For the purposes of the consolidated statement of cash flows, cash and cash equivalents consist of cash and cash equivalents as defined above, net of outstanding bank overdrafts.

(f) Trade and other receivables

If not received at balance date, revenue is reflected in the Statement of Financial Position as receivables. Receivables are carried at original invoice amounts less allowance for doubtful debts. An allowance for doubtful debts is recognised approximating the lifetime expected credit loss of receivables calculated in accordance with AASB 9 Financial Instruments. Bad debts are written off when identified.

(g) Investments and other financial assets

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity. The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the consolidated entity's business model for managing them.

Financial assets designated at fair value through OCI:

Upon initial recognition, the consolidated entity can elect to classify irrevocably its equity investments as equity instruments designated at fair value through OCI when they meet the definition of equity under IAS 32 Financial Instruments: Presentation and are not held for trading. The classification is determined on an instrument-by-instrument basis.

Gains and losses on these financial assets are never recycled to profit or loss. Dividends are recognised as other income in the statement of profit or loss when the right of payment has been established, except when the consolidated entity's benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case, such gains are recorded in OCI. Equity instruments designated at fair value through OCI are not subject to impairment assessment.

(h) Inventories

Trading stock is valued at the lower of cost and net realisable value. Inventories which are not treated as trading stock are held at cost.

(i) Intangibles

Intangible assets acquired are initially measured at cost.

The useful lives of intangible assets are assessed to be either finite or infinite. Intangible assets with finite lives are amortised over a 3 to 5 year useful life and tested for impairment whenever there is indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end. The amortisation expense on intangible assets with finite lives is recognised in the consolidated statement of comprehensive income in the expense category consistent with the function of the intangible asset.

(j) Trade and other payables

Liabilities are recognised for amounts to be paid in the future for goods and services received, whether or not billed to the company. Trade account payables are settled within 30 days.

(k) Provisions

Provisions are recognised when the consolidated entity has a present obligation (legal or constructive) as a result of past events, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

If the effect of the time value of money is material, provisions are discounted using a current rate that reflects the risk specific to the liability.

(I) Leases

The Company assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Company as a lessee

The Company applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Company recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

Right-of-use assets

The Company recognises right-of-use assets at the commencement date of the lease (i.e., the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease term and the estimated useful lives of the assets, as disclosed in Note (m):

If ownership of the leased asset transfers to the Company at the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

The right-of-use assets are also subject to impairment. Refer to the accounting policies in Note (m)(ii).

Lease liabilities

At the commencement date of the lease, the Company recognises lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Company and payments of penalties for terminating the lease, if the lease term reflects the Company exercising the option to terminate. Variable lease payments that do not depend on an index or a rate are recognised as expenses (unless they are incurred to produce inventories) in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Company uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in the lease payments (e.g., changes to future payments resulting from a change in an index or rate used to determine such lease payments) or a change in the assessment of an option to purchase the underlying asset.

(m) Property, plant and equipment

Buildings are stated at cost less accumulated depreciation and any impairment in value.

Plant and equipment are measured at cost less accumulated depreciation.

Land is not depreciated.

(i) Depreciation

Items of property, plant and equipment are depreciated over their estimated useful lives.

The depreciation rates and methods used for each class of asset, for the current and previous years, are as follows:

(ii) Impairment

The carrying values of property, plant and equipment are reviewed for impairment at each reporting date, with recoverable amount being estimated when events or changes in circumstances indicate that the carrying value may be impaired.

The recoverable amount of property, plant and equipment is the higher of fair value less costs to sell and value in use. In assessing the value in use the estimated future cash flows are discounted to their present value using a discount rate that reflects current market assessments of the time value of money and the risk specific to the asset.

For an asset that does not generate largely independent

cash inflows, recoverable amount is determined for the cash generating unit to which the asset belongs, unless the asset's value in use can be estimated to be close to its fair value.

An impairment exists when the carrying value of an asset or cash generating units exceeds its estimated recoverable amount. The asset or cash generating unit is then written down to its recoverable amount. For property, plant and equipment losses are recognised in the consolidated statement of comprehensive income.

(iii) Derecognition and disposal

An item of property, plant and equipment is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal.

Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the assets) is included in the consolidated statement of comprehensive income in the year the asset is derecognised.

(n) Taxation

The company is a non-profit organisation formed for the development of swimming and is exempt from income tax. The company is registered for GST.

(o) Employee entitlements

(i) Wages, salaries, annual leave and time in lieu

Liabilities for wages, salaries, time in lieu and annual leave expected to be settled within 12 months of the reporting date are recognised in trade and other payables and provisions in respect of employees' services up to the reporting date. They are measured at the amounts expected to be paid when the liabilities are settled.

(ii) Long service leave

The liability for long service leave is recognised in the provision for employees' benefits and measured as the present value of expected future payments to be made in respect of services provided by employees up to the reporting date. Consideration is given to expected future wage and salary levels, experience of employee departures, and periods of service. Expected future payments are discounted using the market yields at the reporting date on notional government bonds with terms to maturity and currencies that match, as closely as possible, the estimated future cash outflows.

(p) Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of the goods or services are transferred to the customer at an amount that reflects the consideration to which the Company expects to be entitled in exchange for those goods or services. The Company has generally concluded that it is the principal in its revenue arrangements.

The specific recognition criteria described below must also be met before revenue is recognised.

Membership registration fees

The performance obligation for the Membership Fees revenue is for the Company to provide a platform for participation for individuals to enter into swimming competitions in Australia. As such, revenues are recognised over the membership period.

Swim meet entry fees

Swim meet entry fee revenue is recognised upon providing the performance obligation of holding the event of which the tickets have been purchased. Thus, revenue is recognised at a point in time.

Retail sales

Retail sales revenue is recognised at the point in time when the performance obligation is met at the transfer of the goods to the customer.

Squad income

Squad income is recognised at the point in time when the participant has enrolled or remains enrolled in the relevant swimming coaching program.

(q) Government grants

Government grants are recognised where there is reasonable assurance that the grant will be received and all attached conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the related costs, for which it is intended to compensate, are expensed. When the grant relates to an asset, it is recognised as income in equal amounts over the expected useful life of the related asset.

(r) Other taxation

Revenue, expenses and assets are recognised net of the amount of GST except:

When the GST incurred on a purchase of goods and services is not recoverable from the taxation authority,

in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item as applicable; and

» Receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or payables in the balance sheet.

Cash flows are included in the consolidated statement of cash flows on a gross basis and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the taxation authority are classified as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to the taxation authority.

(s) Fair value measurement

The consolidated entity measures its financial instruments at fair value at each reporting date.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- » In the principal market for the asset or liability, or
- » In the absence of a principal market, in the most advantageous market for the asset or liability.

The principal or the most advantageous market must be accessible by the consolidated entity.

The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The consolidated entity uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

(t) Comparatives

Where necessary, comparatives have been reclassified and repositioned for consistency with current year disclosures.

(u) Significant accounting judgements, estimates and assumptions

The directors evaluate estimates and judgments incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the consolidated entity.

Leases - Estimating the incremental borrowing rate

The Company cannot readily determine the interest rate implicit in the lease, therefore, it uses its incremental borrowing rate (IBR) to measure lease liabilities. The IBR is the rate of interest that the Company would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Company 'would have to pay', which requires estimation when no observable rates are available or when they need to be adjusted to reflect the terms and conditions of the lease. The Company estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates.





Membership Distribution by Area 2024-2025





Membership by Category 2024-2025






