# **SAL Technical Official Reaccreditation Process**

During May this year, SNSW provided feedback to SAL on their proposal to replace the current manual logging of officiating activities with MyLane.

SAL has recently advised that the majority of feedback indicated a preference to continue with the manual system as MyLane does not have the functionality needed to continue to update accreditations. # My Lane - Jacqui Currey

# 1. What Club did you start your swimming career? What Club are you with now?

I started with Beresfield Swimming Club in 2014 and have remained there since.

# 2. What was your first TO credential and what year did you attain that credential?

I started with Time Keeper, Chief Timekeeper and Starter 2015.

# 3. Why did you become an official? Why do you still officiate?

Like most people, the club needed timekeepers each Friday night for our regular club nights. I volunteered and enjoyed it more than sitting in the grandstand, watching a couple of races for my kids, and waiting for the night to be over. With encouragement from our club president, also an active technical official in Coast & Valley, I did the training and theory, then attended an area meet to be assessed on my practical skills. All the other technical officials were so encouraging that I decided it was something I wanted to continue for myself. Since then I have officiated at over 60 meets at area, state and national level, as well as refereeing every Friday night at Beresfield Club. The people I have met, the friends I have made, and the personal sense of accomplishment at creating a fair and encouraging environment which allows the swimmers to compete and achieve their potential, all keep me coming back meet after meet.

# 4. What is the highest credential received

Referee Level 1, Starter Level 1 and AOE

# 5. What is your goal(s)?

My goal is to become a Level 3 Referee and Level 2 Starter. Currently my short-term goal is to be assessed as a Level 2 Referee within the next 12 months.

# 6. What is the highest level meet at which you have officiated

I have recently returned from officiating at the 2017 Australian Age Championships in Brisbane. Prior to that, I officiated at the 2016 Australian Short Course Championships, as well as 2016 & 2017 NSW State Open, 2016 & 2017 NSW Country Championships (including as Referee for one session), 2016 NSW State Age Championships and the 2016 National A Squad Meet.





7. With respect to your answer to Question 6, can you please pass on some of the strategies/tips you used to help you achieve your appointment?

Firstly, just nominate for everything you can be available for and be happy with whatever role to which you are appointed. No matter what position you are in, you can always learn more, especially about pooldeck protocols. Be aware of and watch everything that goes on throughout the meet. Talk to other officials and share experiences. Ask lots of questions to those more experienced TO's at the meet and be open to furthering your knowledge. Know the rules and how to apply them – read the rules before each meet. Take part in the Swimming NSW Technical Official Pathway - I went to B&C Squad Meet in 2015, National A Squad in 2016, and hopefully State Teams in 2017. Attend the Swimming NSW forums and take any opportunity that is offered to you.

# **Competency Assessment of Technical Officials**

When undertaking an assessment, the Assessor should address the task processes, maturity and the understanding shown by the trainee.

The following guidelines have been adopted in a number of rural Areas in order to give Assessors some guidance in the process.

# Competency Assessment

Once the on line training has been completed the member undergoes a basic practical competency assessment to complete the credential. Assessors should be a person other that the Trainer and preferably from another club.

- Inspector of Turns requires a recommended 5 hours of "on deck" practical experience before assessment at an Area Meet.
- Starter requires a recommended 10 hours of "on deck" practical experience before the **two assessments** at an Area Meet.
- Judge of Strokes requires a recommended 20 hours of "on deck" practical experience before assessment at an Area Meet.

This takes into account the long distances between towns and summer only clubs. Some Metropolitan Areas have adopted the position whereby an Assessor from a neighbouring Area assesses their major credential candidates.

The on-deck experience is always under the guidance of a qualified person. In most cases the experienced trainer would recommend the candidate for assessment. It should be remembered that the candidate is able to request assessment.

Area Committees and Technical Coordinators are encouraged to formulate guidelines for Assessors that will allow trainees to progress to Referee without unnecessary delay.

## **FINA Consolidates Growth in the Olympic Programme**

FINA recently announced that the International Olympic Committee approved the addition of three swimming medal events and two women's water polo teams for the programme of the Tokyo 2020 Olympic Games.

In a statement issued on 9 June 2017, FINA President said "The additional medal events are 800 metres Freestyle (men), 1500 metres Freestyle (women) and 4 x 100m mixed medley relay."

"At Tokyo 2020, FINA will become the sport with the greatest number (49) of finals on the Olympic programme, with 35 for swimming, eight for diving, two for water polo, two for marathon swimming and two for synchronised swimming."



# **FINA Rule Changes**

At the recent Technical Congress, FINA made a number of Rule changes for both Swimming and Open Water Swimming. More details will be provided once SAL incorporates the FINA amendments. At this stage it is envisaged that the current Rules will remain in place until approximately October 2017.

# **June Quiz Answer**

To recap on the June question – "You are the Women's Referee for the NSW The Metropolitan Championships. During the first heat of the Women's 16 years and over 200m Individual Medley you notice a Judge of Stroke approaching. As they begin their report a second Judge of Stroke appears and interrupts saying: "You're not going to accept that report, are you?" As Referee should advise the two Judges of Stroke that you are prepared to listen to them both. You should ask the first JOS for their report and then ask the second JOS if he/she has an infraction to report. If they do, the Referee should listen to their report as well.

Both Judges of Stoke have provided their reports to you as the Referee. However, there is a contradiction between the two reports. As Referee, what do you do?

#### **Answer**

As there is a contradiction between the two reports, as Referee you should thank both Judges of Stroke for their report and explain that you would take no action, as there is now doubt in your mind as to the swimmer's action. Note that it was obvious that the two TOs had been discussing the swimmer's action, since the second understood what the first was going to report. The JOS should make their decisions independently. If they have to seek confirmation, they aren't really sure of what they have seen, and shouldn't make a report to the Referee.

You are appointed as an IOT to Lane 9 at the turn end of the SNSW Metro Long Course Championships. The second heat of the Women's 800M Freestyle is in the water. As your swimmer is about to turn at the 150 mark, a coach hands the swimmer in your lane a pair of goggles. As IOT, what do you do?
