CRITERIA

Clause 40.2 of the Swimming NSW Ltd By-Laws Reads:-

40.2 WARATAH RECOGNITION AWARD

- (g) The Company shall recognise outstanding service to the sport of Swimming in NSW by an Individual Member who shall be eligible to receive the Waratah recognition award provided that the nominated member has given at least ten (10) years outstanding service to the sport of Swimming in NSW.
- (h) Candidates for the award may be nominated by any Member.
- (i) The criteria are not based on length of service alone but shall also include the scope of the nominees contribution beyond the norm of ordinary duties of office and may also include swimmer representation for NSW.
- (j) Nominations shall be submitted in writing to the Chief Executive Officer by 31 March each year on the approved nomination form and shall include swimming specific service.
- (k) The Board will determine from the nominations the recipients of the Waratah Recognition Award. No more than three Waratah Recognition Awards will be awarded in any one year.
- (l) The Waratah Recognition Award will be presented to the recipient at an Annual General Meeting. An individual can be awarded a Waratah Recognition Award and Service Excellence Award in the same year.
